The shows will follow MSGA Show Rules and Regulations version 1.5. Ribbons awarded to fourth place in all classes, ribbons and gift certificates for; Grand Champion, Reserve Grand Champion and Best in Show.

Pens - Pen fee is 10.00 which includes one bag of wood chips. If you would like additional bags the cost will be \$6.00 per bag. There is a \$5.00 per stall clean-up fee, if not cleaned by the exhibitor, payable at check-in. Tack stalls, no woodchips, are available at \$5.00 each. The stalls are metal panels originated for goats/sheep. If bringing young kids, you may want to line the stall with mesh or a puppy pen. Hay will be available to purchase if needed, please make note on your entry form.
